

## CONTRACT FOR 2023-2024

### ATHLETIC DIRECTOR

This contract is between the **Mississinewa Community Corporation** of Grant County, Indiana, hereinafter called employer, and **Rich Benjamin**, a person who possesses abilities of an Athletic Director.

#### Witnesseth:

That in consideration of the agreements hereinafter contained said person agrees to perform duties of an Athletic Director for the Mississinewa Community School Corporation in such places as shall be designated by such employer subject to reasonable conditions of employment beginning **July 17, 2023** consisting of **220** days, eight (8) hours per day, and continuing until **June 21, 2024**. Said Rich Benjamin agrees faithfully to perform all the duties of Athletic Director in said school corporation; to use forms and materials as prescribed by said employer, and to observe all reasonable rules and regulations of the properly constituted school authorities. Employee will report to the Superintendent.

Said employer further agrees to pay Rich Benjamin for his services under this contract as Athletic Director in the sum of **\$93,000.00** for the period of contract, said sum to be paid in scheduled installments as follows: **26 payments bi-weekly @ \$3,576.92, starting August 4, 2023 and ending July 19, 2024**. Mr. Benjamin shall be entitled to eleven (11) sick days and four (4) personal days per contract year in which his sick days may accumulate to one hundred sixty (160) days. Mr. Benjamin is eligible for bereavement days as stated in the Master Teacher's contract that occur during Mr. Benjamin's 220 day schedule.

Said employee is eligible to participate in all insurance benefits and will receive corporation contributions according to the Administrative Employee Fringe Benefit Schedule. Mr. Benjamin is eligible to participate in the Public Employees Retirement Fund (PERF) with Employee & Employer contribution paid 100% by MCSC. Finally, Mr. Benjamin is eligible to participate in the 401(a) and 403(b) plans offered by MCSC with employer contribution as stated in the Master Teacher's contract. If eligible, Mr. Benjamin will be entitled to severance pay as indicated in the Master Teacher's contract.

In exchange for the Teacher's services described below, the Corporation and the Teacher agree that:


1. The Teacher shall teach in the schools of the Corporation for the school term, beginning 07/01/2023, and ending on 06/30/2024.
